The 'Asset Lock' mechanism ensures assets are used for the clear purposes set out, the delivery of the Strategic Economic Plan;

However there are some additional compliance requirements, which may bring additional cost and regulations, without adding any significant value to the model.

An incorporated charity model could use a traditional Company Limited by Guarantee model or the newer Charitable Incorporated Organisation Model. However it is unlikely that the activities of the company would meet the requirements for the charitable registration or charitable activities.
