EXECUTIVE SUMMARY

The purpose of this report is to invite the Transport North East (Tyne and Wear) Sub-Committee (TWSC) to appoint its Chair and Vice-Chair for the Municipal Year 2014/15.

1 Background Information

- On 29 April 2014 the North East Leadership Board of the North East Combined Authority adopted its Constitution and thereby appointed its committees, including the Transport North East Committee (TNEC) and the Transport North East (Tyne and Wear) Sub-Committee (TWSC). At the same meeting, following the adoption of the Constitution, the Leadership Board appointed members to the TNEC and also to the TWSC and delegated the appointment of Chair and Vice-Chair of TWSC for the Municipal Year 2014/15 to TWSC. The Leadership Board has acknowledged that the Vice-Chair of TNEC from the Tyne and Wear Authorities would undertake the role of Chair of TWSC.
- 1.2 Whist a Member has been appointed to chair the first meeting of the TWSC held on 29 May 2014, the Committee deferred the appointment of Chair and Vice-Chair of the Committee for the Municipal Year 2014/15 until its future meeting to be held after all constituent local authorities have had their annual meetings. All constituent local authorities have now had their annual meetings and their appointments to the Committee have been confirmed by the Leadership Board on 15 July 2014. The appointments of Chair and Vice-Chair of the Committee are now expected. At its meeting held on 15 July 2014, the Leadership Board has noted this position.

2 Proposals

2.1 TWSC is invited to appoint its Chair and Vice-Chair for the Municipal Year 2014/15. It has been previously acknowledged that the Vice-Chair of TNEC from the Tyne and Wear Authorities would undertake the role of Chair of TWSC.

3.1 Information on the appointment of Chair and Vice-Chair will be made available to all interested parties and published on the North East Combined Authority's website.
